### **ABOUT US**

Since 2015, The Foundry Sheffield CIO has been responsible for the historic Grade II Victoria Hall Methodist Church premises, in Sheffield's city centre. During this time it has begun an extensive programme of renovations, opened the building up to many more people, and set a path towards a sustainable and purposeful future.

Victoria Hall has always been a place of Methodist worship in the city, and this continues to this day. Typical of a Methodist "central hall", it was designed as a concert venue, with numerous rooms for other activities, and acted as centre of mission and social action from its opening in 1907: "a church at the heart of the city, with the city at its heart". It has since been sympathetically remodelled to remain relevant to changing needs and contexts. Under The Foundry Sheffield's stewardship we have maintained the widely recognised and respected public facing identity of Victoria Hall.

Today we provide a home for a community of charities and organisations including Age Active, Assist, Urban Theology Union, DAB Music, The Samaritans, City of Sanctuary and The Sunday Centre. Victoria Hall remains home to active Methodist and other churches.

Built almost 20 years before Sheffield's City Hall, Victoria Hall also has a history as the main city centre concert venue. We are proud to be home to Sheffield Philharmonic Orchestra, and to host a range of musical events throughout the year. In 2022 we replaced the fixed 1960's cinema style seating in our Main Hall with flexible seating, a first step towards our ambition to significantly increase use of this magnificent space for concerts, conferences and other events. A range of smaller rooms and halls allow us to cater for groups from a handful up to 450. Over 1,500 people visit our premises each week.

The Foundry Sheffield is governed by a small and highly collaborative team of trustees, some appointed by local Methodist bodies and some co-opted directly by the board. The board of trustees are a friendly and positive team who willingly work together to steer the charity in the right direction, working with a small staff team of nine and our committed volunteers, keeping the building open 7 days a week 360 days a year.

### **OUR VISION AND PRIORITIES**

The Foundry Sheffield CIO was created by the Methodist church to bring together the expertise and clarity of purpose necessary for Victoria Hall to continue to flourish for the people of Sheffield, without bias, in an ever changing world. We maintain a close working relationship with the Methodist Church, supporting the church in advancing its mission, but intentionally welcome, and work for the collective good of all people without distinction of sex, sexual orientation, age, race or of political, religious, or other opinion, in the heart of our multicultural city.

#### Our core values are to:

- Provide a safe space with good, accessible facilities
- Prioritise people suffering from economic or other marginalisation
- Model positive and respectful relationships with our partners, leaseholders, licensees, stakeholders and clients
- Provide a high standard of hospitality and welcome

During our first decade we have grown our staff team, created policies and procedures to underpin our activities, built new partnerships, increased use of our building, tackled a maintenance backlog and begun a programme of proactive venue enhancements. We now have diversified income streams from shop units, major events and conferences, regular and occasional room bookings and office tenants, supplemented by grants.

We have ambitious plans to continue to redevelop Victoria Hall, making it viable and fit for purpose for years to come. Having survived the coronavirus pandemic, we are alert to the multiple pressures the cost of living crisis will place on the charities we host and us as an organisation. We will need to be strategically nimble to adapt to the changing face of Sheffield's city centre, and networked to foster new partnerships.







## **Being our Chair of Trustees**

### TIME COMMITMENT

- Preparation for and attendance at six board meetings per year. Our board currently meet face to
  face during the working day, but we have always been flexible to adapt to the accessibility needs of
  our trustees, including use of video conferencing technology.
- Membership of some of our board subcommittees, subject to needs and specific expertise. (We
  currently have HR, Buildings and Health & Safety subcommittees, each meeting twice per year. The
  Chair would not be expected to be a member of all subcommittees)
- Meeting with Organisation Manager for support and oversight each month, plus additional ad hoc mentoring and support as required.
- Ad hoc conversations with fellow trustees as required.

#### **ROLE DESCRIPTION**

- With the board and management, define and oversee The Foundry Sheffield's strategic direction and plans
- Hold an overview of The Foundry Sheffield's compliance with its charitable and legal obligations, including its ongoing relationship with the Methodist Church
- With the trustees, maintain a clear grasp of the The Foundry Sheffield's financial position
- · Convene and chair board meetings, in consultation with the Organisation Manager
- Be a mentor and critical friend for the Organisation Manager
- Be an advocate for Victoria Hall/ The Foundry Sheffield amongst key stakeholders
- Act as the final reviewer/ adjudicator for grievance and disciplinary matters
- Speak on behalf of Victoria Hall/ The Foundry Sheffield on relevant occasions
- Support board members individually as appropriate
- Ensure relevant training is made available for trustees, in consultation with the Organisation Manager
- Maintain an overview of Board composition, lengths of service and trustee recruitment

- Bringing a collegiate approach as chair, acting as a first amongst equals
- Experience of strategic oversight, charity governance and senior leadership
- Strong inter-personal skills, capable of relating well to a broad range of stakeholders

- Having a good understanding of and aligned to the ethos and aims of the Methodist Church of Great Britain
